EXECUTIVE SUMMARY

Halfway through 2018, our Freedom of Information-Project Management Office (FOI-PMO) of the Presidential Communications Operations Office (PCOO) has come a long way in strengthening the implementation of the Freedom of Information (FOI) Program in the Executive Branch. Since its creation, we have been responsible for operationalizing the directives set forth in Executive Order No. 2, s. 2016 (EO); through the development of policies, conduct of communications and engagement activities, establishment of monitoring and evaluation mechanisms, and management of the Electronic FOI (eFOI) Portal. Moreover, our Office has extended its efforts in widening the FOI Program's reach and promoting higher levels of civic trust by encouraging government entities outside the Executive Branch to implement the Program.

This document shows our **STRENGTH IN NUMBERS** as we deliver transparency through performance and compliance of National Government Agencies (NGAs), Government-Owned and/or -Controlled Corporations (GOCCs), State Universities and Colleges (SUCs), Local Water Districts (LWDs), and other government offices to the provisions of the EO. This also highlights our milestones and achievements in developing FOI policies, forging partnerships, and establishing a nation of well-informed and engaged citizenry through our enhanced engagement strategies.

The FOI Program is envisioned to reach greater heights this year and our growing team is set to make this possible. We are ready to take on new challenges, create new milestones, and set new directions to make FREEDOM OF INFORMATION the central virtue of our democracy.

DELIVERING TRANSPARENCY THROUGH...

A. AGENCY PERFORMANCE

In our efforts to enhance accessibility to government information, the FOI Program continually widens its reach by creating more platforms for lodging requests. Filipino citizens can now freely access information through our standard (paper-based) form and the eFOI Portal.

The eFOI Portal is designed to provide citizens ease in requesting information, tracking requests, and receiving information online. It also allows government offices to receive, process, and respond to requests efficiently.

WE'RE GROWING OUR NUMBERS...

Agencies Onboard the eFOI Portal

From the initial fourteen (14) government offices onboard in December 2016, the eFOI Portal now has 274 government offices consisting of 184 (or 97%) NGAs, 86 (or 73%) GOCCs, one (1) SUC, and three (3) LWDs. Of the participating GOCCs, it should be noted that the Southern Utility Management, Inc. and Quedan and Rural Credit Guarantee Corporation are under privatization and abolition.

Agency performance in facilitating eFOI requests


The eFOI Portal categorizes lodged requests based on status:

"Successful Requests" are requests in which agencies fully-provided the information demanded by the requesting party.

"Unsuccessful Requests" are requests which may either be invalid, lodged to the wrong agency, or denied due to the application of the exceptions to FOI.

"Pending Requests" are requests currently being acted upon by the agencies.

Lastly, "Closed Requests" are requests which required clarifications from the agencies and which were not responded to by the requesting parties within 60 calendar days.



As an integral part of the features of the Portal, data on the most requested agencies are gathered real-time.


The charts below show the top seven (7) government agencies with the most number of requests received from citizens. These are further broken down according to request status.





B. AGENCY COMPLIANCE


1. FOI MANUALS

The People's FOI Manual serves as the guide of citizens in requesting information from government agencies.

As required by the EO, all agencies under the Executive Branch should publish their People's FOI Manual, which will outline the standard processes in providing public access to government information. The manual should be proactively disclosed through the agency's website, at no cost to the public and in an accessible format.

The following government agencies under the Executive Branch have complied with the directives of the EO through the submission of their FOI Manuals: Lumaki tayo sa isang culture na nahihiyang magtanong. 





2. FOI REPORTS

While requests through the eFOI Portal are regularly monitored by our Office, the number and status of requests lodged through the standard paper-based format depend on the submission of data by government agencies. Pursuant to FOI-MC 2017-01, government offices are required to submit quarterly FOI Registries—a list of all FOI requests received, both standard and online.

A total of 82 out of 190 (or 43%) NGAs and 36 out of 118 (or 31%) GOCCs have submitted their FOI Registries at least once per quarter.

The following summarizes the submissions of FOI Registries per quarter:



SUCs and LWDs have yet to submit their registries in the next semester of this year.


From the 118 NGAs and GOCCs who have submitted their FOI Registries, a total of **3,039 standard** paper-based requests were received and reported. The graph below summarizes the reported standard requests by classification:

Moreover, data from the submitted registries indicate that the average number of days in processing of FOI requests is seven (7) working days.



3. INFORMATION INVENTORIES

The Agency Information Inventory is the master list of all government information held by an agency including the title, description, and file type of each information. The list will provide the scope and limitations of the information that can or cannot be requested from an agency. Information is classified according to the following disclosure categories:

- for public consumption
- for agency consumption only
- under the exceptions to EO No. 2
- with corresponding charges
- available only to specific persons and/or entities

In summary, a total of 78 (or 25%) NGAs and GOCCs submitted their Agency Information Inventories.







A. STRENGTHENING POLICIES



Through the initiative of the Department of Budget and Management (DBM) and PCOO, FOI Program requirements had been included under the Good Governance Condition for the eligibility to grant Fiscal Year (FY) 2017 Performance-Based Bonus (PBB). The Memorandum Circular (MC) No. 2017-1 issued by the Inter-Agency Task Force on the Harmonization of National Government Performance Monitoring, Information and Reporting Systems (Administrative Order No. 25 s. 2011) includes the online publication of the People's FOI Manuals on the agency's Transparency Seal pages as part of the eligibility criteria.

The PCOO issued FOI-MC No. 1 on 7 March 2018 in order to guide government offices for the timely submission of the 2018 FOI Reports. All agencies are required to submit their reports in digital format based on the template and schedule provided.

Task Force AO 25 issued MC No. 2018-1, providing the Guidelines on the Grant of FY 2018 PBB under EO No. 80 s. 2012 and EO No. 201 s. 2016 on 28 May 2018. One of the identified criteria is the compliance of government agencies to the enhanced FOI Program requirements.

support the issuance of the Administrative Order No. 25 s. 2011, the PCOO issued FOI-MC No. 2 on 18 June 2018, which provides the FOI Program Criteria and Validation Process for the eligibility to FY 2018 PBB. Concerned agencies shall request for validation by sending an email to our Office and attaching the direct links to following: People's FOI Manual signed by the head of agency; the Agency Information Inventory; the 2017 and 2018 FOI Summary Reports; the 2017 and 2018 FOI Registries; and a visible and hyperlinked FOI logo in the agency's homepage.

Our Office issued memoranda stating legal opinion to assist government agencies (such as the Climate Change Commission and the Department of Health) in interpreting the list of exceptions to the FOI.

B. FORGING PARTNERSHIPS

The FOI Advisory Committee

Within the first year of implementation of the Program, our Office realized that there is a need for an organized body, which will provide strategic direction to the operationalization of the EO. On 2 February 2018, an FOI Policy Consultation Meeting was organized to discuss important policy issues on FOI implementation and establish an FOI Advisory Committee.

The meeting was attended by representatives from key national government agencies, civil society sector, the business sector, and the academe: DBM; DILG; Department of Justice (DOJ); National Privacy Commission (NPC); National Archives of the Philippines (NAP); Right to Know, Right Now! (R2KRN!) Coalition; Caucus of Development Non-Government Organizations Network (CODE-NGO); Philippine Chamber of Commerce and Industries (PCCI); De La Salle-Jesse Robredo Institute of Governance (DLSU-JRIG); and University of the Philippines National College of Public Administration and Governance (UP NCPAG).

As a result of the consultation, the PCOO submitted a draft Memorandum Order on the Creation of the FOI Advisory Committee, for approval by the Office of the Executive Secretary.

C. ENGAGEMENT ACTIVITIES

In the first half of 2018, our Office has participated in and/or conducted a total of nine (9) orientation sessions, thirteen (13) technical onboarding workshops, nineteen (19) collaborative meetings, and 28 FOI-related activities. These activities aim to increase awareness and build capacities of major stakeholders of the FOI Program. Notable engagement activities are detailed below.











FIRST NATIONAL INFORMATION CONVENTION

On 19 February 2018, the first National Information Convention was held in Davao City. The event gathered over 1,000 participants from the government sector, the local and national media, the academe, and communications and technology industry leaders.

The objective was to strengthen partnership between public and private sector communicators.





OPEN DATA DAY PH 2018

In celebration of International Open Data Day, Bantay Kita, Hivos, R2KRN! Coalition, NPC, and the PCOO organized a workshop entitled Building a Community of Practice around the Right to Information and the Right to Privacy on 2 March promoted 2018. The event constructive engagement and encouraged dialogue amongst stakeholders on achieving balance between the public's right to know and an individual's right to privacy. The event was attended representatives from national government agencies, civil society organizations, the business sector, and the academe.

ROUNDTABLE DISCUSSION ON OPEN RESEARCH

On 3 March 2018, the Institute for Leadership, Empowerment, and Democracy, with support from the Open Knowledge International and Scholarly Publishing and Academic Resources Coalition (SPARC) convened a roundtable discussion on Open Research in the Philippines as part of the International Open Data Day celebration. The event invited university libraries, research units of colleges and universities, student organizations, and government and private research institutions to discuss and promote open data research in the country.



6TH CIVIL SOCIETY ORGANIZATIONS

NATIONAL CONFERENCE ON TRANSPARENCY
AND ACCOUNTABILITY INITIATIVES IN THE

On 16 April 2018, various civil society representatives from Luzon, Visayas, and Mindanao attended Bantay Kita's conference entitled Towards Empowered Communities Claiming Space, Amplifying Voices. PCOO Assistant Secretary and FOI Program Director Kris Ablan joined the panel on Human Rights and the Right to Information.

PHILIPPINE OPEN-GOVERNMENT PARTNERSHIP WEEK 2018

Themed Going Local: Bringing Government Closer to the Citizens, the two-day workshop showcased and explored localization efforts on open governance and transparency initiatives. It also paved the way for discussions focused on ongoing Open Government Partnership (OGP) commitments which can be implemented at the local level. Our Office encouraged the LGUs to issue local FOI ordinances through the Ph-OGP subnational platform. The workshop was co-organized with the DBM, PCOO, Hivos, and Bantay Kita.



SUBMISSION OF THE JOINT LETTER APPEAL TO THE HOUSE OF REPRESENTATIVES

On 22 May 2018, our Office, together with the R2KRN! Coalition and key partners from government and civil society gathered at the House of Representatives to personally deliver a joint letter addressed to Congressman Karlo Nograles, Chairperson of the House Committee on Appropriations. The joint letter appeals for the consideration of the House Substitute Bill on FOI for the next Committee hearing and subsequently refers the said bill to the Committee on Rules for second reading. Co-signatories include the PCOO, DBM, DOJ, DILG, NPC, NAP, Department of Information and Communications Technology, R2KRN! Coalition, PCCI, CODE-NGO, UP NCPAG, and DLSU-JRIG.



INTERPELLATION OF THE SENATE BILL ON FOI

On 23 May 2018, our Office met with civil society organizations at the Senate of the Philippines in preparation for the interpellation of the FOI Bill on 28 May 2018.





YOUTH SPEAK FORUM

On 17 June 2018, our Office set up an FOI booth during the Youth Speak Forum, an annual event organized by AIESEC for young and senior leaders which aimed to provide an avenue to initiate discussions on national and global issues particularly peace, justice, and strong institutions.


