WHEREAS, Executive Order (EO) No. 2, s. 2016, was issued by President Rodrigo R. Duterte on 23 July 2016 to operationalize the People's Constitutional Right to Information and the State Policies to full public disclosure and transparency in the public service;

WHEREAS, Memorandum Order No. 10, S. 2016, designated the Presidential Communications Operations Office (PCOO) as the lead agency in the implementation of EO No. 2, S. 2016, and all other Freedom of Information (FOI) programs and initiatives, including the electronic FOI in the Executive branch;

WHEREAS, the FOI Awards was established in 2017 to recognize the efforts of government agencies, individuals and organizations that contributed to the development and progress of the FOI Program;

WHEREAS, as a yearly activity of the Freedom of Information – Project Management Office (FOI-PMO), the screening period of potential awardees to the 2021 FOI Awards that will be conferred on the fourth week of November 2021 is on 16 July 2021 until 31 August 2021;

WHEREAS, to promote open, transparent and accountable governance, the guidelines for the 2021 FOI Awards was established through FOI-Memorandum Circular (MC) No. 01, S. 2021;

WHEREAS, Section 4 of FOI-MC No. 01, S. 2021 provides that the FOI Awards Secretariat, composed of the FOI-PMO headed by the Chief of Compliance Monitoring Division, shall submit list of nominees to the FOI Awards Committee;

WHEREAS, Section 6 of FOI-MC No. 01, S. 2021 established the FOI Awards Committee shall be composed of the following: a representative from the Office of the Executive Secretary, who shall also act as the Chairperson; a representative from the FOI-PMO; and one representative each from the academe, the business sector, and a Non-Government Organization/Civil Society Organization. Each of them shall have equal voting rights.

WHEREAS, The FOI Awards Committee shall evaluate and validate the potential awardees based on the criteria set under FOI-MC No. 01, S. 2021, within thirty (30)

days upon receipt of the list from the Secretariat. The list submitted by the Secretariat shall be for the consideration of the Committee which may amend such list as necessary. The Committee shall choose the winners among the final list agreed upon by its members.

The Criteria for the best FOI Officers are as follows: (a) Formally designated as FOI Officer, either through Special Order or as indicated in the agency's FOI Manual; (b) Active participation in FOI Activities; (c) Providing reasonable assistance to the requesting party; (c) Agency's Overall Rate; (d) Compliance to PBB Requirements; (e) Providing with a receipt or acknowledgement upon lodging a request within a reasonable timeframe; and, (f) Resolving simple and complex requests within the mandated period.

organizations who demonstrate exceptional or significant contribution to the FOI program's progress and development.
